## **MINER'S ART & ANTIQUE MARKET 2017 Guidelines**

**GENERAL INFORMATION:** The Miner's Art & Antique Market is scheduled for August 19, 2017, and runs from 11 am to 6 pm. An \$25.00 entry fee is due by August 14.

**ADMISSION:** Admission to MA'AM is regular Museum admission: \$8.50 adults, \$7.00 seniors, and \$5.00 youth. Underground Tours are an additional cost. For regular admission costs guests have the opportunity to see the Museum, explore the quilt show and buy unique wares!

**ART:** If you make it, it's art. All items must be handmade. In order to ensure the quality of the show, vendors are requested to keep their art specific to their specialty.

**ANTIQUE:** All items sold in the market must be considered antique or vintage. Contemporary items or reproductions are not permitted. Items should be displayed in a clean and organized fashion.

**CANCELLATION POLICY:** Before August 14, 2017 all fees are refundable. August 14 or later full payment is required and nonrefundable.

**EMERGENCY CONTACTS:** In case of emergency, the emergency contact on the application will be notified. An emergency contact should be provided by all vendors. The World Museum of Mining will not be responsible for vendors or their possessions.

**ENTRY FEE:** \$25.00 due by August 14, 2017. Make checks payable to **WORLD MUSEUM OF MINING**. If entry fee is not received by this date, vendor will forfeit their booth. Returned checks will be charged a \$25.00 fee.

**FOOD VENDORS:** All food sold at MA'AM must be cleared by the Butte-Silver Bow County Health Department. It is up to the vendor to ensure that they have the appropriate license. Proof of license must be on file by August 14th or food vendor will forfeit their booth.

**LIABILITY:** The World Museum of Mining will not be responsible for injury, loss or damage that occur to lessee on signing the contract, the vendor expressly releases the aforementioned from any and all claims for such loss, damage or injury. By signing this application, vendor indemnifies and holds harmless the World Museum of Mining.

**PETS:** NO PETS will be allowed in the market area as the Museum is a no pet facility. Service dogs are permitted with appropriate papers.

**PHOTOS & PROMOTION:** Vendors are asked to submit five photos representing their wares with their applications. Short descriptions are also requested explaining who you are and what you sell. Photos and descriptions submitted will be used for promotional purposes. **The Museum wants the community to know who you are, where you will be and what you are selling!**

**SET UP:** Set up will start at 6:30 am on the day of the event. No early set up is available. Vendors will set up within the Museum perimeter. Gate access is available for vehicles for set up and tear down after the Market. All vehicles need to be removed from museum grounds by 10:45 am.

**SMOKING:** The World Museum of Mining is a nonsmoking facility. No smoking is permitted on site during the Market. If you plan to smoke, you can exit the grounds through the gift shop and cross the parking lot.

**SPACE ASSIGNMENTS:** All booth spaces will be assigned by the MA'AM committee. All vendor booths are outdoors.

**SPACE REQUIREMENTS:** All booth spaces will be 10' deep by 10' wide. This area must be kept clean. Vendors must provide their own tents. No electricity is available in the market area. If you are bringing a generator, please note that on your application. **NOTE: The area does tend to get windy. The Museum will have some weights available on a first come first serve basis. If you have your own, please bring them. Water spigots are available to fill buckets for weight also.**

**TABLES AND TENTS:** Tents must be provided by each vendor. The World Museum of Mining does have a limited number of tables available. Please indicate on your application if a table is needed. The Museum will supply one chair to each vendor. If additional chairs are needed, please make note of this on your application.

**TEAR DOWN:** Vehicle access gates will open at 6:00 pm for tear down. If items must be removed before market close, all items will have to be packed out by foot.

**VEHICLES:** Due to liability and guest access, vehicles will not be permitted in the market area from 10:45 AM to 6:00 PM. This is for the safety of Museum guests.

The Chateau Quilt Guild is also presenting a Quilt Show in St. Helena's Church within the Museum grounds. Categories include:

- A. Butte 12" x 12" square
- B. 50+ year old quilts
- C. Quilt made with traditional blocks.
